dispute solutions

adjudication, arbitration or mediation, or providing litigation support.

For extension of time claims alone there are a variety of methods such as impacted as-planned, time impact analysis or collapsed as built. We can compile any claim either from first principles or develop a claim your team has already compiled. Alternatively, we can train your team to compile the claim themselves in order to save costs.

commercial solutions

A commercial department should cover its own costs, i.e. the financial consequences of not having it is greater than the cost of having it. However, your

company may not be large enough to justify the the cost of a full time commercial manager.
